8. Nominees, nominators or referees may be contacted for further information by Jellis Craig Boroondara staff.

9. Jellis Craig will notify all nominees of their nomination within 2 weeks of receiving a valid nomination. At this time, nominees will receive a copy of their official nomination form, including the names of their nominator and referee.

10. Individuals or groups may be nominated for more than one category. However, each individual or group can only be nominated once per category.

11. Individuals or groups who are nominated for a Jellis Craig Boroondara Community Award may be considered for a category other than the one they are nominated in.

12. All enquiries and submitted information regarding the awards will remain confidential (except for winners) unless permission is obtained by Jellis Craig Boroondara.

13. All judges' decisions are final, and no correspondence will be entered into relating to the decision.
